5. Any and all Intellectual Property Rights with respect to the services and the BIOTENIC PHARMA Proprietary Material and all modifications, improvements, enhancements, or derivative works made thereto, shall always belong to BIOTENIC PHARMA or its licensors and HIMT College of Pharmacy shall not be entitled to claim any rights therein. All rights, title and interests in data of HIMT College of Pharmacy shall always remain with BIOTENIC PHARMA.
6. The parties agree that they are bound exclusively by this memorandum and will not be at liberty to enter into any other agreements or arrangements with any third party without reference to the other party in this MOU on the similar training and internship program(s).
7. **CONFIDENTIALITY:** During the term of this MOU, each party should maintain the Confidential Information at any circumstances. Confidential Information shall mean all information marked "Confidential" or under any similar legend indicating the confidentiality of the information or information which by its nature is confidential such as instrument details, protocols, procedure, raw data or any property of the facility etc.
8. This MOU does not constitute any component of financial obligation between HIMT College of Pharmacy and BIOTENIC PHARMA at the time of confirmation but a minimal financial obligation will be applicable for the students/ faculties opting to join the training/internship program provided by BIOTENIC PHARMA.

9. **TERM:** This MOU shall be valid from the 11-09-2025 and shall remain in force for 02 (two) years from the Effective date, unless terminated earlier by either Party as provided herein below.
10. Either party may terminate this MOU by giving 30 (thirty) days notice to the other party. On termination, each party shall return to the other party all such confidential and proprietary information, documents, raw data and reference material of the other party in its possession.
11. All such obligations and terms of this MOU that are required to survive the termination of this MOU shall survive such termination.
12. **PERIODIC REVIEW:** The Parties agree that the person's nominated herein below as the point of contact for each party (or their respective nominees) shall meet at least once in a year or inbetween if required. Both the parties will provide a report on the program made in this regard through e-mail to accomplish the objectives of this MOU as per the mutually agreed time schedule.

The venue of Arbitration shall be New Delhi. Both parties irrevocably submit to the exclusive jurisdiction of the Courts in New Delhi, for any action or proceeding regarding this MOU.


