**Agree as follows:**

1. **Joint Incubation: Research and development by the team of faculties, students of HIMT COLLEGE OF PHARMACY, GREATER NOIDA-201310 (UTTAR PRADESH) and engineers of TECHNOLEDGE EDURESEARCH Pvt. Ltd., Noida.** The schedule of such project and product may be finalized with mutual agreement.
2. **Recruitment of Graduate Trainee** specifically from students from **MCA/MBA/BCA/BBA.** The students will be associated on joint projects/products development. The selection of students would be done jointly by **HIMT COLLEGE OF PHARMACY, GREATER NOIDA-201310 (UTTAR PRADESH) and TECHNOLEDGE EDURESEARCH Pvt. Ltd. Noida.**
3. The decisions on the number of students to be associated per project will be done jointly by the **HARLAL INSTITUTE OF MANAGEMENT &TECHNOLOGY, GREATER NOIDA-201310 (UTTAR PRADESH)** and the **TECHNOLEDGE EDURESEARCH Pvt. Ltd., Noida** based on

the requirements of such trainees needed for the respective project and product development.

4. The students associated as trainees would be paid reasonable stipend per month by **TECHNOLEDGE EDURESEARCH PVT. LTD., Noida**.
5. **TECHNOLEDGE EDURESEARCH PVT. All the operational and management control will be provided completely by **HIMT COLLEGE OF PHARMACY, GREATER NOIDA-201310 (UTTAR PRADESH)**. The Institute will ensure all the facilities and representatives of **TECHNOLEDGE EDURESEARCH Pvt.Ltd., Noida** will have to abide all the rules applicable on them under the Institute.
