

**Second Position- Vanshika (D. Pharm Ist year student).**

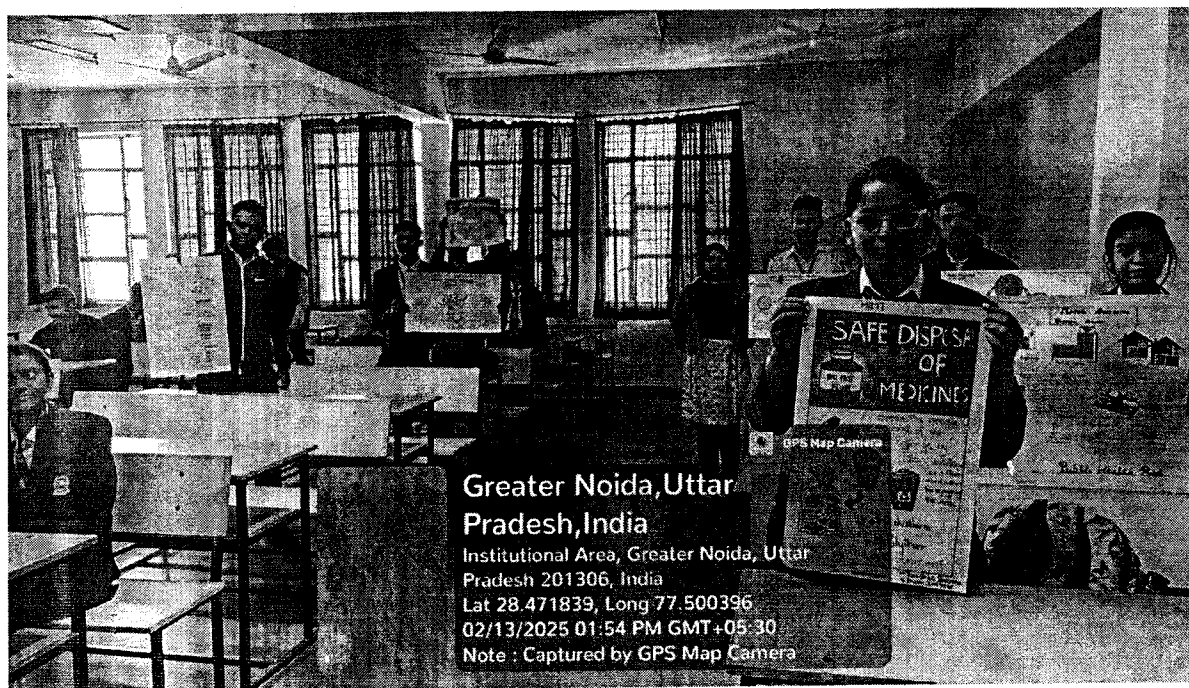
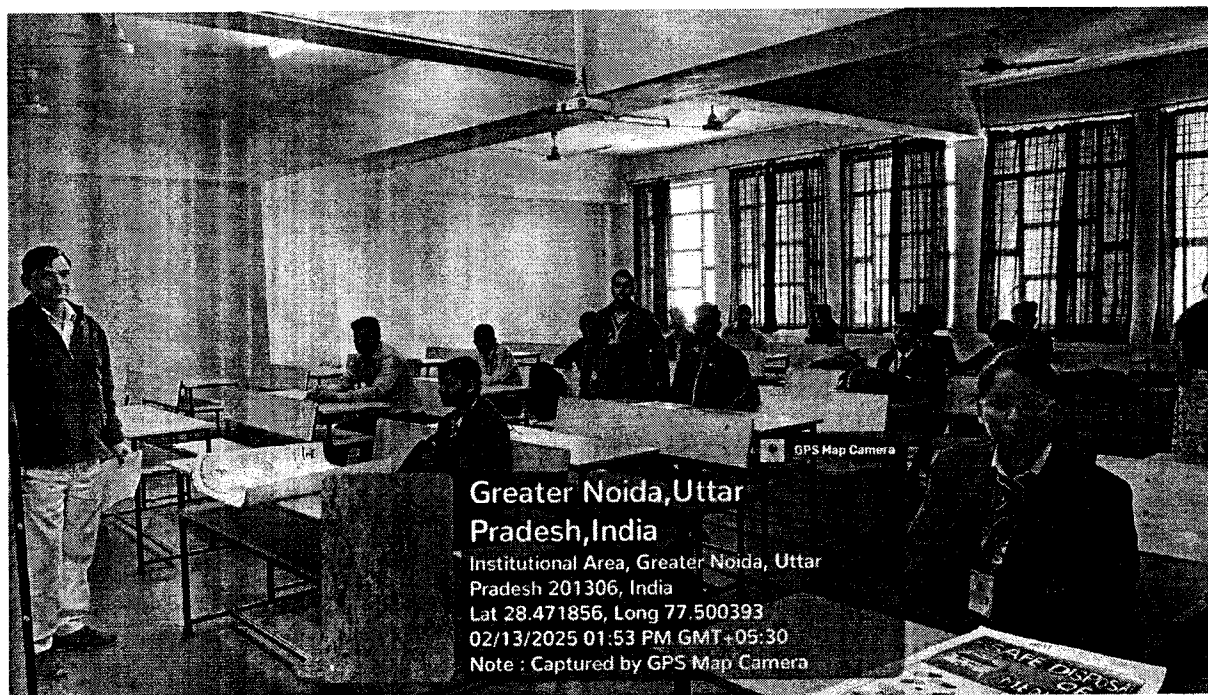
## **Conclusion:**

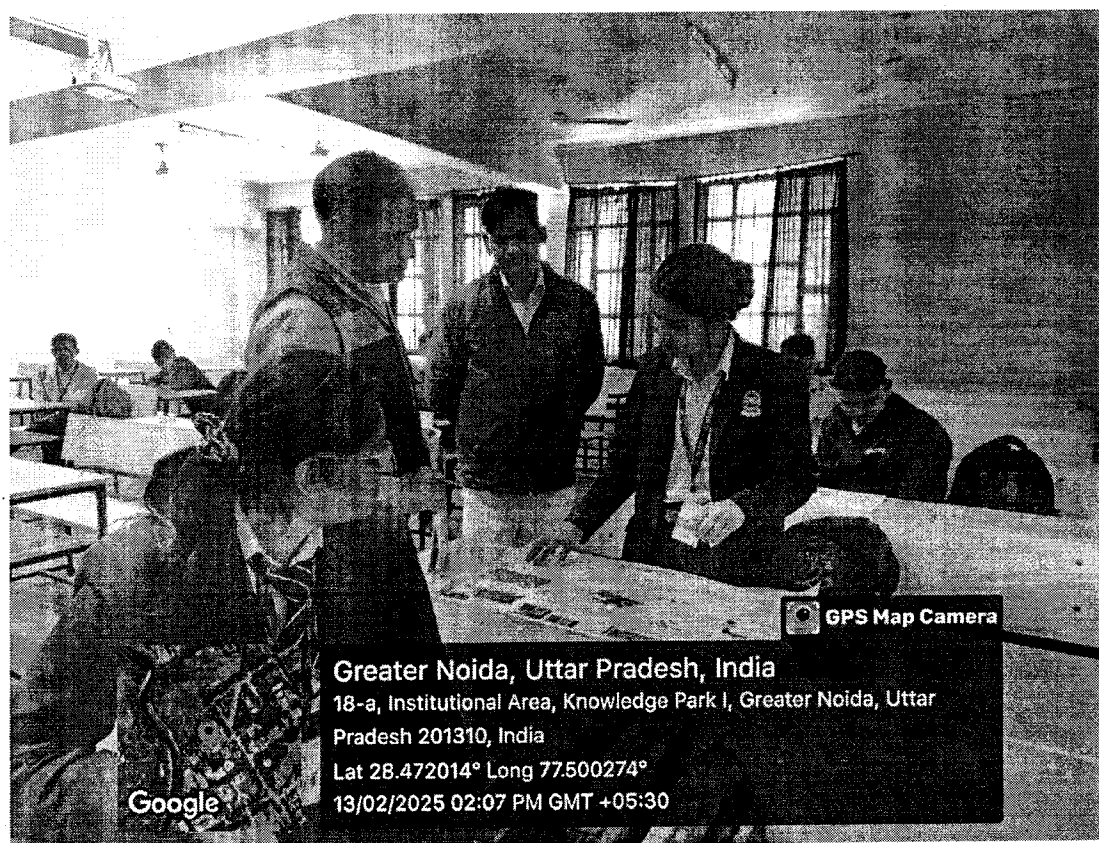
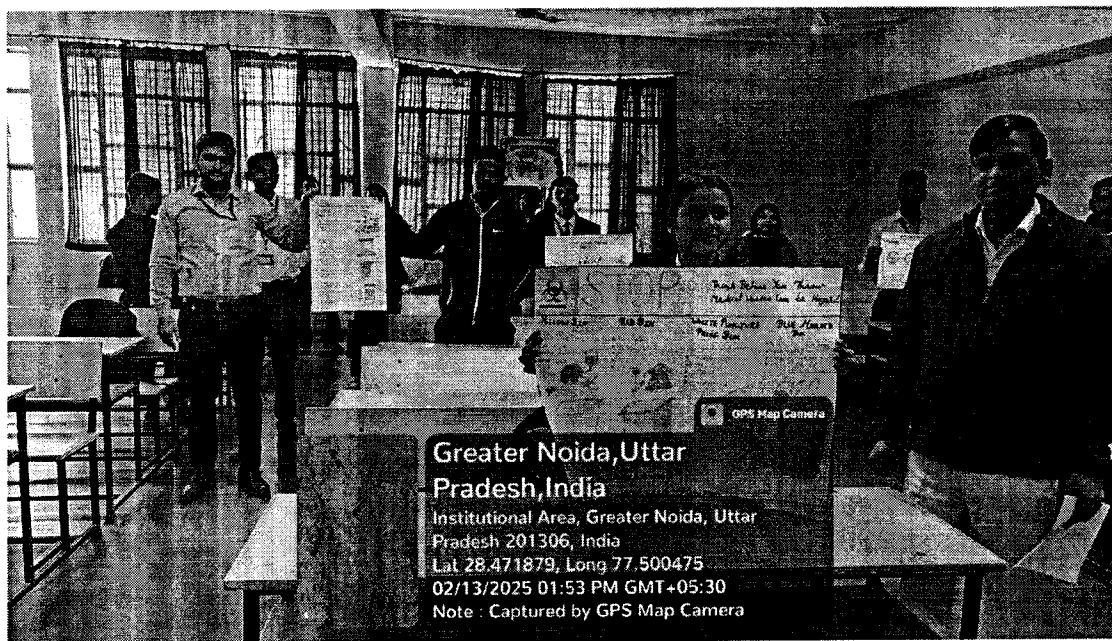

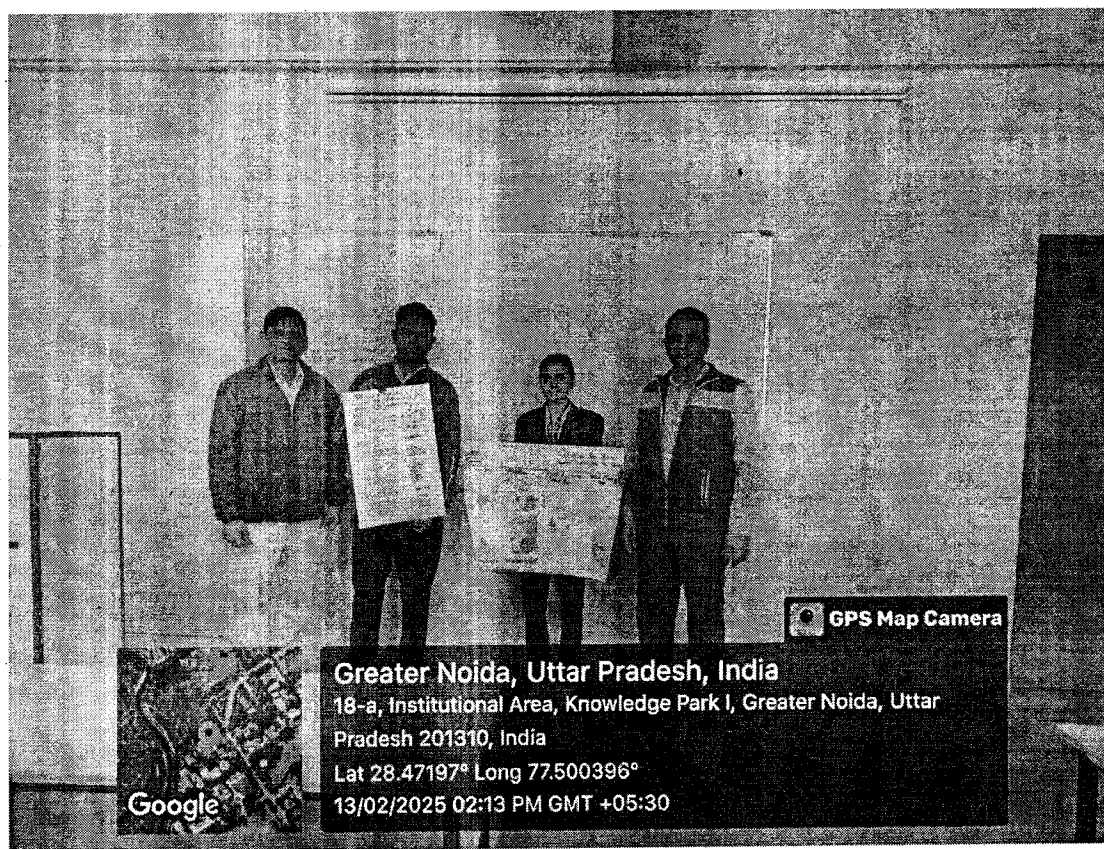
